Commissioner Gray thanks Chief Rizzo for the discussion and explanation of the program and the agreement. He states he was very transparent about it and points out that he is correct in what he said about being permitted to discuss the terms of employment and conditions in executive session however the discussion was not the original issue to him and was that there was never any public

action to approve the agreement. Commissioner Gray asks Solicitor Alexander if he is correct in stating that discussion can be had in private but action has to be in public. Solicitor Alexander states generally action has to be in public on any contract but subsequent ratification cures any violation of the Sunshine Law. Commissioner Gray states this should have happened in December and in January, but it didn't, and to him is a failure of leadership. Commissioner Zona states this contract does not cost the Township one penny and not spending any money. This service is free to the Township. Commissioner Gray states it is still a legal agreement that has to be voted on in public. Commissioner Zona states he takes offense to the idea that the Sunshine Law was violated, he does not feel it was, and that the Board did what they did in good faith and listened to the solicitor. Commissioner Stump agrees with Commissioner Zona and states when the Board is in executive session, they rely on guidance from the solicitor as to what is Sunshine Law and what isn't and feels the Board went by how they were guided.

- 11) Motion to approve the \$6.00 monthly cost for extra recycling carts consistent with the extra trash cart service under the Waste Management contract.

Commissioner Stump states a smaller container is being provided and recycling generally provides an income stream to the garbage company and she would like to see the amount lowered to four dollars instead of six dollars. She states that would require an addendum to the contract. Mike Turley states this would need to be discussed with Waste Management. Commissioner Stump states there are a lot of constituents that are upset over the increased garbage fee and was out of our control. Commissioner Haigis agrees with Commissioner Stump and should try to encourage people to recycle and see if Waste Management would agree to four dollars for the extra recycling cart. Mike Turley states the Board has valid concerns and will speak with Waste Management.

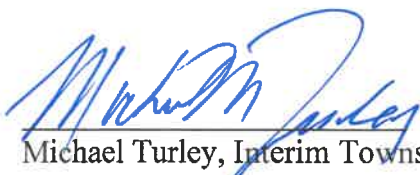

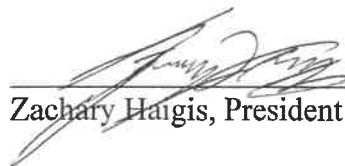
