OPENING PRAYER – Pastor Michael Cole – Calvary Assembly Church

CITIZENS INPUT

Rosanne Novotnak – 2491 Mickanin Road – states she is here on behalf of the Norwin Chamber of Commerce requesting the Commissioners reconsider their succession from the Chamber. She states the logo states we are “connected” and believes the Chamber is a bridge between the communities, businesses and school district. She provides the 2021 community resource guide Board and hope they will reconsider the membership.

Julianne Fehrenbach – 12460 Longview Drive – states she is here to raise a concern with the Waste Management pickup for yard waste. She states she does not have a large property but a massive amount of leaves blow into her yard. She contacted Waste Management and was told there are three weeks in both the Spring and Fall for yard waste pickup. She is concerned about the dates in Fall because they were still disposing of yard waste the week of Thanksgiving last year. She is hoping an option would be to provide extra dumping at the Municipal Building.

RESPONSE TO CITIZENS INPUT

Commissioner Stump states she believes the membership was cut by Jeff Silka when trying to find different places in the budget to cut as to not have to raise taxes. She states the Township is marketing itself online. Commissioner Zona states he would be interested in reconsidering the membership but would like to look it over and discuss next month. Both Commissioners Gray and Gass also agree. Ms. Novotnak states the yearly membership cost six hundred ninety dollars based on the amount of employees.

Mike Turley states this is not a frequent complaint and what she was eluding to was Thanksgiving week to still dispose of yard waste. He states this was recently modified to push that week later to accommodate. As far as the six weeks, that is the way it has been for many years with the three weeks in the Spring and three in the Fall. He recommends for her to call the Administration Office tomorrow with her information and we can contact Waste Management. Commissioner Zona asks if a dumpster could be placed at the Public Works Department for disposal of yard waste. Mike Turley states that can be looked into, but there are some side issues of people going down there and dumping things. Commissioner Zona states even if tags were permitted to ensure it is only yard waste being dumped and not other things. Commissioner Gray asks how would this be policed what people are dumping. Commissioner Stump states she is concerned with storm damage resulting in a lot of debris and may want to offer composting programs.


