Solicitor Dice states this public hearing is being held to consider public input with respect to the application for Importation of Liquor License, Pursuant to PA Act 141 of 2000, of 1688 Asian Food Inc. The property where the liquor license is requested for is 1688 Asian Food Inc., 12120 Route 30, Suite 170, North Huntingdon, PA 15642.
