NORTH HUNTINGDON TOWNSHIP – BUSINESS GROSS RECEIPTS TAX
ORDINANCE #1085

- Payment due date is May 15 of each tax year. Tax must be paid in full by this date to avoid penalty and interest.
- Penalty – Must be added to payments made after May 15 at 1% of unpaid tax for each month or fraction thereof.
- Interest – Must be added to payments made after May 15 at 1% of unpaid tax for each month or fraction thereof.
- Business License Fee - \$10.00 per year. License will be issued when tax is paid in full for the year. License must be conspicuously posted at each place of business at all times.
- Tax Form – All lines must be completed to avoid return of form due to incomplete filing.
- Proof of Gross Receipts - A copy of your business federal income tax return or work papers containing calculations used to determine amount of gross receipts reported, must be attached to completed form.
- Manufacturing and Non-Profit Entities - Proof of Manufacturing exemption must be sent with final return. License fee of \$10.00 per year must be enclosed.
- Cost of Goods Sold – Is **NOT** an allowable deduction
- **Filing Federal Extension** – Interest & Penalty are not excused on extensions. Estimated payment should be made until final return can be filed. Refunds will be processed if estimate is overpaid.
